Community Planning

- 32.4 Million in Grants Awarded and administered.
- 227.3 Million in loan requests evaluated.
- **58** Million water projects developed.
- 1,200 Hours of professional assistance in Economic Development & Planning.
- 251 Maps Produced for projects or decision making.
- 1,892 E911 structures updated or collected.
- **170** Transportation safety, planning, and funding coordination engagements.

Aging & Social Services

- **2049** Friendly visits made by the Nursing Home Ombudsmen. Visits were only completed part of the year due to COVID closure of visitors to the Long-Term Care
- **463** Homebound elderly received in-home services. Despite restrictions due to Covid Pandemic.
- 637 People were able to hire a caregiver of their choice through our Medicaid waiver Participant Directed Services program.
- **5041** People guided toward assistance by the Aging & Disability Resource Center
- 338,904 Meals were served to 3240 seniors. This shows 73,692 number of meals increase from last year and 862 more seniors from last year due to efforts by the Governor to ensure everyone aged 60+ given access to our meal program during the COVID pandemic pandemic.
- **231** Caregivers and Grandparents received respite/supplemental services through the National Family Caregiver Support Program.
- **9137** People were assisted through the State Health Insurance Assistance Program.

Workforce Development

- 11 Hiring events and Job Fairs conducted.
- 60 Direct contact services provided to job seekers
- 85 Employers assisted at Hiring Events/Job Fairs.
- 133 Occupational skills credential or degrees obtained by program participants.
